1 Ticket Index

Ticket Number	Short Description
2116	The Registration form now implements the optional password preference correctly.
1967	New menu option to ignore the patient that is showing as open.

2 General

Optional Registration Password:

The patient password was showing as mandatory on Registration even when the user preference to allow optional passwords was selected by the user.

Ignore Patients Not Open:

(1967)

A new option has been added to the right-click content menu to allow the user to instruct RecordConnect to ignore the patient that is showing as open. The local clinical systems can mistakenly tell RecordConnect that a patient is open on the workstation when they are not. This option tells RecordConnect that this patient is not actually open and to continue with the other patients.

3 Upload Form

Applicable to both the Initial Health Summary and Event Summary uploads.

Upload Size Warning:

(2098)

A user preference has been added to display a warning when an upload exceeds a user specified size. The user may elect to proceed with the upload or to change the selected items to reduce the size. RecordConnect also now has a maximum limit of 350Mb per upload. An upload greater than 350Mb must be reduced by the user by removing selected items before the upload can proceed.

Pending Uploads Warning:

(1980)

RecordConnect will now display a warning to the user if pending uploads (ie uploads that have been previously requested but have not yet been uploaded over the internet) have been pending for greater than 2 days or the number of queued uploads is greater than 5. A right-click context menu item allows the user to manage the pending uploads if the queue is not making suitable progress.
